The class is free and open to the public; refreshments will be available.



KING COUNTY COUNCIL REDISTRICTING

Voters in November 2004, amended the King County Charter to reduce the number of County Council districts from 13 to nine and to direct redistricting to draw new district boundaries.

On November 22, 2004, the Council appointed four King County citizens to serve on an independent Districting Committee that would meet, hold public hearings, and file a new districting plan, a map of the county designating nine new council districts of equal population.

Two public hearings were held and two committee meetings open to public (1/7/2005—2:00 pm (Council Chambers, 10th Floor, KC Courthouse for final drafting) and 1/8/2005—10:00 am (same location for public comment). All hearings will be taped and retransmitted by KC Television on Comcast Cable 22 or Millennium Cable 72/80. Online testimony is available through: http://www.metrokc.gov/council/districting/

January 12, 2005 (tentative) - 9:00 am, Southwest Room, KC Courthouse, 12th floor—review of public testimony and work toward adoption of plan.

Saturday January 15, 2005, - 10:00 am in KC Council Chambers, KC Courthouse, 10th floor — ADOPTION OF FINAL DISTRICTING PLAN

You may view the four proposed plans at the website listed above.

The Districting Committee and not the County Council adopts the final plan.
