Washington State Democrats—Spring Meeting in Pasco Report

The Washington State Democratic Central Committee met in Pasco on April 1-2, 2005, for its Spring Quarterly Meeting. Here are some of the highlights from the meeting:

2005 Nominating Process

As a result of recent court rulings, legislative action and the passage of Initiative 872, the party is planning to nominate its own primary candidates this year. In the event that the legislature does not take further action, the Rules Committee passed "Rules for the Selection of Candidates and Nominees for Public Office" that was adopted by the body. In short, PCOs will be called to represent their precincts in a nominating convention before July of this year. This process was adopted because of the short preparation time in 2005. For those of us in King County, it affects the following positions: King County Executive and the nine King County Council seats. The text of the Rules were sent to KCDCC Officers and King County—Legislative District Chairs, 4/2/2005.

As for 2006, the Rules committee will draft procedures to be considered and adopted again by the full State Committee. Although the timeline has not been finalized, it is very likely that the 2006 process to nominate our candidates will be by the 2006 Caucus system.

Financial Review/PDC Compliance

Because of the recent relapse of reporting certain financial disclosure documents to the FEC and PDC, the State Committee adopted a resolution that authorized Chair Paul Berendt to contract with an external compliance review officer to review reports for accuracy and the State Party Finance Committee be charged with reviewing the reports and notes from the external reviewer at each regularly scheduled meeting.

King County Democratic Central Committee Meeting Minutes—Tuesday March 22, 2005

The meeting was called to order ten minutes early to introduce and thank all of the groups participating in the Grassroots Festival that started at 5:30 pm. This was followed by the flag salute and adoption of meeting agenda. Acceptance of previous meeting minutes made with correction of "poll observers" to "poll workers."

Special Guest King Council Chair Larry Phillips addressed the group. Motion 1, move to endorse Larry Phillips halted. Motion 2 to suspend rules, passed 23 Yes, 4 No. Motion 3 to table until all speakers completed talks and discussion, passed 16 Yes, 9 No.

King Council Member Bob Ferguson talked to the group followed by talk by the Honorable Mayor of Seattle Greg Nickels.

The Main Program—Democracy for Washington—was presented by Executive Director Ray Minchew.
Review of tabled Motion for early endorsement of King County Council Chair Larry Phillips passed unanimously.
Officer and Committee Reports:

Chair.—Honors Banquet netted \$4,200. The Chair asked for help in securing energy issue speakers for the next meeting in Shoreline. She also discussed the upcoming "New Candidate Training Course—101", scheduled for March 30, 2005.

First Vice Chair Report.—no report; absent.

Second Vice Chair Report.—no report; absent.

Third Vice Chair Report.—Budget performance report introduced and discussed.

Fourth Vice Chair Report.—Elections Report—April 2nd Poll Worker Training course was noted; scheduled meeting with King County Elections management for April 4; Special Election in May will be conducted by mail ballots.

Candidate Recruitment Committee.—Update on members.

Bylaws, Platform and Procedures.—brief committee meeting was held before general meeting; no platform update this year.

Endorsements Committee.—Lila Smith, member, said she hoped endorsements will not all be early ones.

Program Committee.—Planning for May in progress. Legislative Action Committee.—Update on legislation in Olympia (Simple majority for school levies; mental health bill, safe sex health bill in Senate, emission standard bill passed the House, and health care bill passed the Senate) and in Washington, D.C. (Bankruptcy bill in the House—calls to Congressman Adam Smith are needed, and Fast Track—calls to Congressman Jay Inslee are needed).



State Committee Report.—Congressional District Strategy Sessions are set: March 29th—7th CD at Town Hall, Seattle; April 16th—8th CD at Renton Technical College, and April 23rd -9th CD at the Renton Carpenters Hall. State Committeeman Javier Valdez discussed the 2005 Nominating Convention rules that were to be considered at the upcoming State meeting in Pasco, April 1-2, 2005. Rules will be set for the Partisan County races in Snohomish and King Counties as well as LD Representative Vacancies in Southwest Washington.

New Business: Resolution from Chair Lila Smith of the 32nd District Democrats, concerning the WSDCC reporting violations suggesting an independent audit by new committee made up LD reps. Substitute motion was passed to send resolution to WSDCC Judicial Board to review the violations. (ed: in correspondence with WSDCC Attorney it was discovered that there is nothing in WSDCC by-laws and charter covering fiduciary responsibility of WSDCC Chair and the judicial board could not review. KCDCC Chair sent apology to KCDCC officers and LD Chairs and suggested that the 32nd move their resolution forward at the upcoming State meeting which they did. KCDCC Chair also wrote by-laws change to include fiduciary responsibility of the Chair, sent to Rules Committee Co-Chair and other members.)

Fifth LD Chair Kayne McGladrey introduced motion to favor HB1515 instead of HR4207; passed unanimously. Everyone was encouraged to write to their Olympia delegations. New Energy Future advocacy of the New Washington Coalition—Motion made to support a "New Energy Future" - passed unanimously and was sent to US Senator Patty Murray.

Old Business: The failed 31st District Democrats resolution from the February meeting (regarding Pam Roach's actions) was discussed by Alex Stephens who will work with the Procedures committee to write another resolution. Motion was passed to approve closure of the Pioneer Square office of the KCDCC and move to the home office of the Chair on April 15th.

Good of the Order:

District Chairs Report indicated a multitude of activities: 5th LD—conducting a consolidated District/DFW meeting and working on local issues documents. The 32nd LD is hosting a forum with King County Council candidates, planning a picnic, and working on women's caucus and a progressive caucus. The 34th LD held Issues Forum and planning for District canvassing. The 36th LD—canvassing District on social security issues and making new logo. The 37th LD is having a PCO dinner before their next regular meeting. The 41st LD indicated a Reichert watch group has been formed.

Katie Evans introduced a plan for a new website to help the boycotting of fox advertisers and asked for webmaster support.

Adjourn.

Precinct Committee Officers (PCOs)

We have 2,689 precincts in King County and with the newly appointed/acting PCOs input by the Legislative District Chairs now have 1313 filled positions (as of 4/10/2005). That's a percentage of 48.8% full. We have a lot of vacancies to fill!

Think about becoming the neighborhood leader in your area — become a Precinct Committee Officer in your Legislative District. Become the go-to person in your neighborhood for the latest information regarding the Democratic Party — hold neighborhood meetings, attend meetings and events. You will also be a voting delegate at the upcoming 2005 King County—Nominating Convention on June 28, 2005, location TBD.

Access the KCDCC website at www.kcdems.org for a good definition of a PCO and fill out the application available online. There is also an online training course available for viewing at the site or for using as an online presentation in a classroom format.

And, District Chairs, when you receive and have the applications approved, remember to send them to the KCDCC office by mail, e-mail, or by FAX (425.255.1634). Let's do the grassroots work now and be ready for the upcoming elections with leaders in every precinct.

New Candidate Training

The first King County Democrats— "New Candidate Training—101" was held on March 30, 2005 at the Renton Carpenters Hall. Thirty-five guests signed in. Former KCDCC Chair Greg Rodriguez and 41st LD State Committee Woman Sharon Mast conducted the course with special guest, King County Council Member Dwight Pelz.

Along with an online presentation, there was much lively discussion and anticipation for the follow-on course to be held in May. Each attendee was given a packet that contained a CD (including online presentation in 3 formats, instructor script, flyers, letters, and links), copy of presentation, PDC forms, PCO Hand guide, League of Women Voters TRY brochures, and the KCDCC brochure.

Updated CD's including the rough draft for the 201 course were given out at the Washington State Democrats meeting in Pasco at the Chairs meeting on April 2, 2005. The coursework may be presented in other counties as dates/locations are identified. The updated CD's will be available to all King County LD Chairs at the next meeting of the KCDCC.


