

WAL-MAR SHOULD PAY FAIR SHARE OF HEALTH BENEFIT COSTS—by Mike Murphy

I was pleased to see The Olympian comment on an important issue before the Legislature — what to do about large employers shifting health care costs to the rest of us. The most obvious example is Wal-Mart, one of our nation's largest and most profitable employers. Wal-Mart is big and wealthy, but it does not provide decent health care benefits for its employees.

Should we be concerned about how Wal-Mart treats its employees? Wal-Mart and its allies say this topic should be no concern to the public or the Legislature. I see it differently.

Wal-Mart follows a business model of providing minimal health care, which it knows will shift costs to taxpayers and other employers. A recent news article said more than 3,100 of Wal-Mart's employees in Washington are on taxpayer-funded health care plans.

This practice by Wal-Mart and some other large employers has a direct impact on the entire state. The cost to taxpayers is estimated at tens of millions of dollars a year.

This is unfair to our state treasury, to communities across Washington, to business and to families. Our Legislature must step in. That's why I decided to support the "Fair Share" bill.

The bill sets a minimum for the state's largest employers and targets the worst corporate abusers. For companies with 5,000 or more employees, the bill requires them to spend at least 9 percent of payroll on health care or pay the difference into the state's health care fund. That's a reasonable minimum. The vast majority of companies that size already meet the standard. The bill is supported by businesses, working families, elected officials, health care professionals, and community and civic leaders. This bill can help address the growing number of uninsured children and adults in Washington, now estimated at more than 600,000 people.

Health care is a national crisis, and we do need comprehensive change. But as we work to bring change nationwide, we can't ignore growing abuses of the present system by Wal-Mart and other large employers. We must stop the "race to the bottom" by unfair employers.

This legislation will have two important benefits. First, employees at Wal-Mart and other companies would get improved health care for themselves and their children. Second, and perhaps more important, taxpayers would no longer provide an unintended subsidy to corporations whose employees are on the taxpayer-funded Washington Basic Health Plan. Wal-Mart and its allies have tried to characterize this bill as anti-business. This is the same argument that failed in Maryland, where similar legislation was passed into law.

Many small and larger businesses support the "Fair Share" bill because it levels the playing field. Fair-minded employers shouldn't be paying higher premiums to offset the irresponsible few. Fair-minded employers should not be penalized for doing the right thing. Wal-Mart has a well-documented history of questionable treatment of its employees. It's time to pass this legislation and help put a stop to abuses of our health care system.

Precinct Committee Officer Training

Immediately after the Senate Alito confirmation, someone asked cynically, "Why are you a Democrat?"

I answered with my elevator speech, "I believe the Democratic Party is working for the improvement of social, cultural and economic lives of Americans. We are reclaiming Democracy by working for a safe, stable and prosperous future for our families and the citizens of King County and America."

At the 2005 **Precinct Committee Officer Training** in Lacey, WA, Michele Cotner, PCO and Campaign Consultant, urged us to format a speech that we could deliver in less than one minute. The ideal statement, she taught, contains a clear statement of belief, two prominent core values and four statements that express those values. Assuming you have less than a minute to establish credibility, the short speech is a first step in more effective communication.

We covered a lot of material at the all day seminar. With the 2004 election fresh in our minds, we felt proud of our accomplishments. There was some discouragement because of the National election but we realized change was possible with a lot of hard work and openness to new ideas.

The most significant part of the training was *FRAMING 101* where we learned to use positive value statements in communications with voters in our precincts. The training was based on the book *Don't Think of an Elephant*, by George Lakoff. Everyone came away with a new way of speaking and thinking about political issues. One of the ideas we investigated was how Democrats lost the support of voters in the 2004 National election on issues like *Tax Relief*, *War on Terror*, *Gay Marriage*, *Social Security Crisis*...

We learned that Democrats could have more influence on voters by rephrasing the terms to define our own values. One example, NeoCons used the phrase *TAX RELIEF* to justify the tax cuts to the wealthiest citizens. Thinking about it, who doesn't want RELIEF? The Democratic view is: Big Business has deserted America and is not paying their fair share. Tax money invested wisely has benefited in highways, schools and colleges, military and transportation to name a few. We should have reframed the phrase to *PROTECTING TAX SUPPORTED INFRASTRUCTURE* to gain the support of our constituents.

The most glaring example of our failure to put events in a proper frame concerns the levee failures in New Orleans. In 2001 several agencies including the US Army Corps of Engineers warned the President of an imminent disaster if a simple levee reconstruction project wasn't completed. Typical of Bush mismanagement, the Crawford Village Idiot cut the levee project funding. Proving the axiom *Murphy was an optimist*, the worst natural disaster struck, thousands died, tens of thousands were left homeless and billions in commerce were lost. The sound bite that Democrats allow is, "Who could have foreseen a levee failure?" We never reframed the truth to our values. Instead of saying "...the victims of Katrina," or "...the damage caused by hurricane Katrina," we should use the phrase, "...the victims of the levee failure in New Orleans."
