

Across the nation, the battle is on to save the values Democrats hold most dear. On the gulf coast victims of Hurricane Katrina are fighting Bush administration bureaucrats (and cronies) to rebuild and protect their own neighborhoods. In our nation's capitol the religious right is attempting to drown out the voices of reason on appointments to our highest court.

In our region, nowhere is this battle over values more fierce – the consequences more stark - than in the race for King County Executive.

Democrat Ron Sims has been a visionary force for every value we care deeply about: from protecting family wage paychecks to creating ten of thousands of new jobs; from building a wall against sprawl to preserving hundreds of thousand of acres of green space; from getting light rail back on track, to bringing real reform our health care system; from fighting for equality and justice, to defending children, seniors and the poor.

At every turn, Ron Sims has been proud to wear the label "Democrat" and unashamed to stand up for our core beliefs.

Perhaps that is why the Republicans have focused on him like a laser beam, uncorking a Karl Rovian concoction of specious allegations and last-minute election tricks designed to get just enough Democrats to think twice, maybe even sit this one out.

Don't fall for it.

The person picked to lead the effort to keep you seated is one David Irons, a candidate backed by the Bush/Cheney Republican machine, far-right ideologues and gambling lobbyists. Someone with a less than stellar track record in the private sector he claims as his strong suit. Someone who has worked overtime on the public dime (as a member of the County Council) trying to defeat democratic values.

Our message to them on November 8th: "Sorry, we're not buying."

Here's why:

Ron Sims and Leadership

Ron's record as County Executive is unmatched. He is known nationwide as a leader unafraid to make tough decisions and willing to stand up for every member of our community.

Ron's Fiscal Leadership

Since becoming Executive in 1996 Ron faced serious budget shortfalls head-on, making the cuts and increasing government performance, while protecting services to the most vulnerable. He reduced the number of county departments from 13 to 9, cut \$137 million, eliminated a chronic structural deficit and earned the county one of the highest credit ratings in the nation; all of it during one of the worse economic downturns in recent memory.

Irons and fiscal management: bankrupt ideas. A person who is anchoring his campaign on private sector experi-

ence has a decidedly mixed record. Irons helped steer his Brigadoon company into bankruptcy and dissolution.

Ron's Environmental Record

Ron is a national leader in environmental protection. When he became Executive there were only 24,000 acres of farm land and open space in preservation – today there are over 125,000 acres. Ron has protected endangered salmon, prevented California-style sprawl from engulfing King County, preserved our rural areas for future generations, pushed for new clean air and clean water protections, and invested in hybrid and bio-diesel technologies in the Metro bus fleet. Ron is building the state-of-the-art Brightwater treatment plant to protect Puget Sound from unclean wastewater discharge.

On parks, trails and recreation, Ron is simply the best. Under his leadership King County's regional trails network has grown to over 175 miles - including the newly opened East Lake Sammamish Trail - with a commitment to building 300 total miles.

Irons and the environment: unhappy trails. Irons has long opposed rules to prevent sprawl and protect open space. He fought the popular East Lake Sammamish Trail, opposed funding for expanding Metro bus service, and even proposed a study to build a \$1.4 billion mega-freeway through the Snoqualmie Valley.

Ron Sims and Transportation

Ron's strong opposition to I-912 (the transportation funding repeal initiative) has deep roots. When state funding for transit disappeared, Ron led the successful effort protect Metro transit service.

Ron led the successful turnaround of Sound Transit and got light rail going. Construction is underway on a system that will swiftly move riders from downtown to the airport.

Ron Sims has been a leading advocate for replacing the Alaskan Way Viaduct and the 520 bridge and the first major public office holder to declare his strong opposition to I-912.

Irons on 912 and transportation: go figure. His party supports it and initially, the republican refused to take a public stand on I-912 (Seattle P-I editorial 10/9/05). After considerable public pressure, he now says he's against it (Seattle P-I 10/13/05). Which Irons should we believe? Irons has long opposed light rail, voted against preserving Metro transit and other common sense traffic solutions.

Jobs, Jobs, Jobs

Ron Sims' record on growing family wage jobs is a matter of record. The Brightwater treatment plant alone will bring more than 20,000 high wage jobs and a half billion dollar payroll to the region, including more than 6,000 in the construction trades. Light rail construction, which Sims championed, is putting thousands to work right now. As County Executive, Sims created employment programs for developmentally disabled adults to provide them with independent means of living. Sims' King County Job Initiative prepares thousands of lower income people to move up to higher wages by offering invaluable training.

Irons and jobs: where's the beef? Irons appeared at rally in Woodinville last month to oppose the Brightwater plan, which he had previously voted for (Seattle Times "

"Brightwater Foes Rally" 10/9/05). He opposed light rail from the beginning. (Irons/McKenna press release 1/8/02)

Southwest Airlines

After a thorough review of proposals from Southwest and Alaska Airlines (as required by federal law), Ron rejected the proposals to move to Boeing Field because they failed three critical tests – laid down by Sims – that could not be overcome (noise, traffic and public subsidy).

Irons on Southwest: cloudy skies. According to the Seattle Times, Irons appeared to both support and oppose the Southwest move <u>at the same</u> <u>time</u>. It all depended on his audience (Seattle Times "Irons says Southwest Statements consistent" 9/23/05).

Health Care Reform

Ron is leading a four-county effort to reform our broken, inefficient health care delivery system. The Puget Sound Health Alliance, which he chairs, represents over 700,000 workers and families members and places the employee's health – not profits - at the center of reform. For King County employees, Ron has improved the quality of care and radically lowered cost growth - without cutting benefits.

Iron's leadership on health care reform: unknown.

Justice & Equality

Ron has an unequaled record defending justice and equality for all people. After the passage of I-200 he ensured that disadvantaged businesses would still be able to participate in county contracts. Sims has created employment programs for the developmentally disabled, and a fully-accessible Metro bus system.

Throughout his career Ron has fought for the extension of full civil rights for all. On the council he successfully fought attempts to overturn the county's ordinance banning employment discrimination based on sexual orientation and ensured domestic partnership benefits for county employees.

Ron supports marriage equality and last year worked with lesbian and gay couples to bring a suit now before the Washington State Supreme Court, examining the constitutionality of Washington State's Defense of marriage Act (DOMA)

The Irons record on equality and justice: the jury has made its verdict. Irons organized against a 2005 ordinance barring discrimination based on gender identity, and opposed an ordinance requiring county contractors to provide equal benefits to domestic partners.

For those who hold democratic values close to heart, the stakes in this election couldn't be higher. The choice couldn't be clearer. Please join me in supporting Ron Sims, Democrat for King County Executive.

Ron Sims has dedicated his life to public service. After graduating from college he worked in the Consumer Protection Division of the Washington State Attorney General's office. He later went on to the Federal Trade Commission where he fought against consumer fraud and abuse. Recruited to run the City of Seattle's juvenile offender program, Ron remained head of the program until becoming a legislative aide in the Washington State Senate.

An active volunteer, Ron has a long history of community involvement. As a lay minister Ron volunteered for Operation Nightwatch, which serves homeless individuals in the City of Seattle. A long-time football and baseball coach for the Rainier Valley sports leagues, Ron was also a regular tutor at Meany Middle School for many years. Founder of both Pista sa Nayon, Seattle's Filipino American Community Festival, and the Paul Robeson Scholar Athlete Awards, which honors young athletes who excel in education, Ron's community dedication has been felt in every corner of the Puget Sound region. An election observer for the Carter Center in both Zambia and the Republic of Georgia, Ron's public service career expands well beyond Washington State. Ron is a member of both Boule and the Alpha Phi Alpha fraternity.

It was Ron's term as Board President for South East Effective Development (SEED) - a neighborhood advocacy organization focused on economic development located in southeast Seattle - that launched his political career.

Previous meeting minutes and agenda were approved.

Resolution Regarding Scheduling Caucus in 2006

Whereas the large turnout for the February, 2004 Caucuses was not due to their being held on a Saturday but rather was attributable to the highly contested and aggressively pursued Presidential nomination campaigns, to the lack of a true Presidential primary in Washington state, and to the amount of anger toward the policies of President Bush;

Whereas the proxy system in 2004 was not effective in safeguarding or enabling the participation of Democrats **who observe certain religious faiths**, thereby disenfranchising a major segment of Democratic supporters and voters;

Whereas to insist on Saturday caucuses discriminates against those of certain religious faiths, just as it is considered inappropriate to hold the caucuses on a Sunday due to the conflict with other religions.

Whereas to hold the caucuses on a Saturday, results in greater costs for rental of caucus sites;

WORSE THAN WATERGATE

10/28/2005—Democratic National Committee Chairman Howard Dean issued the following statement:

"This is a sad day for America.

"Beyond the evidence that the White House manipulated the intelligence used to justify the war in Iraq, a group of senior White House officials not only orchestrated efforts to smear a critic of the war, but worked to cover up this smear campaign.
