1. What is your strongest area of legal expertise?

The State should support more of the funding. A system of unified courts including municipal and district courts would allow a more even distribution of funds. State funding would also preserve some of the independence of the municipal courts who are currently dependant on the executive and legislative branches. Although this is always the case in small municipalities this dependence can be tense.

3. What recommendations do you have for increasing access to the judicial system (Civil and Criminal)?

I hate to mandate pro bono service and would likely not support such a mandate, but the system now does not encourage or even give meaningful acknowledgement to those of us that volunteer our time. A system that rewards pro bono work in both the criminal and civil arenas would be a great asset. In the Civil arena many of the proposals now included in I-336 would help access by lowering litigation costs and preventing big business from driving out valid claims.

I have given a great deal of pro bono time to help mostly veterans.
